The Chairman, Deputy-Chairman, Honorary Secretary and Honorary Treasurer are ex-officio members of the Executive Committee.

The Council in presenting the Annual Report for 1979 wish to thank all the Collectors for their continued efforts in making the collection such an outstanding success.

Contributions received by the Fund during its calendar year 1979 totalled £82,570.10 and a further £1,095.23 from Civil Service and Post Office subscribers was sent direct to the RNLI., including donations made by Deeds of Covenant. The splendid overall total of £83,665.33 was almost 60% above the 1978 figure and 30% more than the previous record total of £64,180 achieved in 1976. Administrative costs were again kept at an exceptionally low level and over 95% of all the money collected was sent to the RNLI., mainly as advance payments towards the cost of the new lifeboat for Northern Ireland. Full details are given in the audited accounts on pages 8 and 9 of this Report. Your Committee wishes to express its deep gratitude to everyone who has subscribed to this fine response to the 1979 appeal, and its appreciation of all the work of the Departmental and Post Office collectors.

Our latest lifeboat the Silver Jubilee Civil Service No. 38 was named by H.R.H. Princess Margaret on 21st November 1979 and is now on station at Margate. For record purposes the Civil Service and Post Office have subscribed and purchased the following lifeboats for the RNLI and contributed towards their maintenance whilst in service.

The Annual Meeting of the Council to the fund was honoured by the presence of the Deputy Director of the RNLI Mr. J.R. Atterton M.B.E. who kindly addressed us on recent developments in the RNLI.

### CIVIL SERVICE AND POST OFFICE LIFEBOAT FUND

**26th March 1980**

It is most kind of you to have invited me to attend your Annual Meeting and I thought I would start by telling you one or two things that have developed in the last year affecting the RNLI.

The most important item is, of course, the Naming of the Margate Lifeboat "Silver Jubilee". This was a great success, although there were certain last minute problems. Princess Alexandra was most anxious to undertake the ceremony but was taken ill at the last moment. Fortunately Princess Margaret kindly agreed to step in, but on the actual day she was in Nottingham and bad weather developed and she was unable to fly to Manston and had to come by train. As you know the ceremony was a great success despite the typical Lifeboat weather. The Institution is extremely fortunate in the support it receives from members of the Royal Family.

As you know the Institution maintains a 24 hour back-up service for the Lifeboat Stations and on this occasion the plaque had already been engraved stating that Princess Alexandra was attending the function; our Depot at Poole managed during the night to

produce a new plaque with Princess Margaret's name. This was greatly appreciated by everyone at Margate.

Last year one of the main events was the International Lifeboat Conference in Holland. In 1978 when I had the pleasure of addressing this meeting I told you of the work undertaken by the Institution as the Permanent Secretariat of the I.L.C. This is a Conference which meets every 4 years when Lifeboat services, which either run on a voluntary basis, like the RNLI, or by the State, as in the case of the United States Coast Guard, meet to exchange ideas in design, operation and Search and Rescue procedures. I am very pleased to be able to say that the Institution, in its demonstrations of the Atlantic 21 type Lifeboats, which your fund has provided at Southend, and of the Arun type Lifeboat, similar to the Fund's Lifeboat at Torbay, were claimed by all the overseas delegations as some of the finest Lifeboat equipment in the world. There is no doubt that the RNLI is still the world's leading Lifeboat authority.

During the last year the Institution has developed the Medina type Lifeboat, which is an intermediate boat and the first boat was displayed at the Boat Show in January this year. The boat is named "Mountbatten of Burma". I should explain that Lord Mountbatten a few days prior to his death had agreed to the first Medina type Lifeboat being named after him, and for an Appeal to be made for funds to cover the cost of the boat. In view of his sudden death, the Institution wondered whether they should go ahead with the Appeal but after consulting the family we were asked to do so. I am pleased to say that the Appeal was exceedingly well subscribed and reached its target of £100,000.

Last year the Institution's Lifeboats were launched 2,514 times and rescued 973 lives, including the rescue of 60 lives from the Fastnet race and the towing in of 12 yachts.

Our work continues. As you know this year we saw a large ship ashore near Brighton when the Shoreham Lifeboat took off the whole of the crew.

May I again say that the Committee of Management of the Institution is very grateful indeed to all those who support your Fund. One of the main reasons, if I may say so, is that unlike inflation which is an unknown quantity, the Institution is able to rely on your Fund to maintain a steady increased income.

The Civil Service and Post Office Fund lifeboats were launched in 1979 on 115 occasions and rescued 38 lives. The Fund is now responsible for rescuing over 3,600 lives.

Your Secretary who left the Civil Service in 1976 has reluctantly decided that he must resign and Miss C.H. Henry M.B.E. was appointed Secretary in his place.

## THE ROWLAND HILL MEMORIAL AND BENEVOLENT FUND

THE ROWLAND HILL BENEVOLENT FUND exists to relieve distress of Post Office operational staff and their dependants. In 1978/79 almost 1,000 individuals were assisted by means of free grants or interest-free loans. The majority of these were the widows of former Post Office staff whose only income was that provided by the Department of Health and Social Security. The assistance that the RHBF can give in these cases makes a great difference to their happiness and comfort. In addition, the fund is now able to assist Post Office pensioners to obtain sheltered accommodation.

**WILL YOU HELP** to provide the cash to enable the RHBF to increase the amount of help it can give? There are many former colleagues or their dependants who are much worse off than you are. A subscription of a few pence per week is all that is required.
